- ☞ Chaired by Sheepmeat Council (SCA)
- ☞ Secretariat provided by SCA
- ☞ Consists of lamb finisher representatives from each state

What is the aim of ALF?

- ☞ To ensure that the R&D needs of ALF are reflected in SCA policy and lobbying
- ☞ To keep the industry sector aware of events, activities and lamb finishing issues
- ☞ To distribute information relevant to the sector via the SCA newsletter
- ☞ To provide an avenue for intensive lamb finishers to have their say on industry issues

What are the priorities of the Australian Lamb Finishers Group?

- ☞ The development of a Code of Practice for the Intensive Lamb Finishing sector
- ☞ The Code will address animal health and welfare, nutrition, feedlot design, environmental and management issues
- ☞ The Code will be developed over the next 18 months via extensive industry consultation
- ☞ The Code will be developed under the guidance of ALF, SCA and MLA
- ☞ Improve traceability
- ☞ Work with industry to ensure NVD meets industry needs and is relevant
